This ‘joke’ heightened fears in students, parents and school officials. We won’t tolerate people terrorizing our community, and we will charge them where we see fit.”

And it’s not just teenagers. Adults are not immune. If you’re caught making this type of threat, you could be charged with Interference with Staff, Faculty or Students of Educational Institutions – a crime that carries up to 18 months in jail. Then we’ll see who is laughing.
